On November 7, 2019, at approximately 1600 hours, Ms. Sheila Matthews came into the Griffin Police Department and provided a number of documents and e-mails as well as a prepared statement where she alleged that a series of criminal acts had occurred concerning documents she requested and/or received from the City of Griffin in regards to a series of Open Records Act requests. A preliminary review of the material did not disclose venue (who had jurisdiction) nor did the material establish criminal intent nor the basic elements of any crime. In the material provided by Ms. Mathews, she alleged that she was denied a particular document (regarding a Facebook post by Mr. Will Sanders) but she produced the same document she said she was denied.
