The City of Griffin has no public record responsive to "an official copy of the attached document that was previously produced to Kyle Peltz, CNN or HLN." We decline public disclosure for the origin of the hard copy that was provided, which you already have, based on Georgia Code Annotated §50-18-72 (a) (3) Exception of certain records, "Except as otherwise provided by law, records compiled for law enforcement or prosecution purposes to the extent that production of such records is reasonably likely to disclose the identity of a confidential source, disclose confidential investigative or prosecution material which would endanger the life or physical safety of any person or persons, or disclose the existence of a confidential surveillance or investigation."

There is no charge for this response which completes and closes ORA-19-00440.

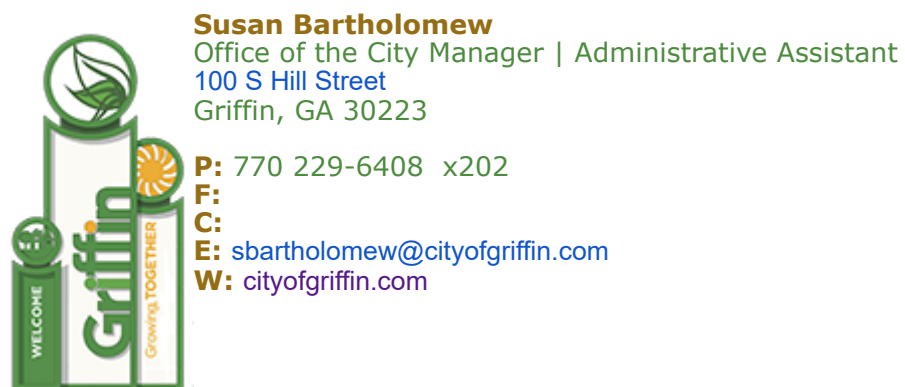
